### Introduction

This guide provides information about the proceeding for the submission of project proposals in the frame of the **5<sup>th</sup> EU-LAC Joint Call 2025**.

**Part I consists of frequently asked questions and answers.**

## I. General Information for Applicants

### What is the EU-LAC Interest Group?

The EU-LAC Interest Group was founded in March 2017 in order to maintain and carry forward the bi-regional network built by the EC-funded ERANet-LAC project (2013-2017). It consists of 29 funding agencies from both regions wishing to cooperate in bi-regional science, technology and innovation (STI). The activities organised by the EU-LAC Interest Group aim to support the implementation of the Common EU-LAC Research Area and to create further added value to its four pillars: mobility of researchers; increased thematic cooperation to address global challenges, international outreach of research infrastructures and innovation.

So far, EU-LAC funding agencies successfully organized four joint calls: Between 2013 and 2017 the 18 ERANet-LAC partners carried out two transnational joint calls, followed by two joint calls organised by the EU-LAC Interest Group in 2017/2018 and 2022.

### Which are the fundamental principles of the 5<sup>th</sup> EU-LAC Joint Call?

The EU-LAC Joint Call for collaborative research and / or innovation projects is a transnational research support instrument developed by the funding institutions participating in this call. It is implemented through a coordinated funding scheme whereby each funding party is funding its own national scientific team within a multilateral project (“virtual common pot”). Their budget is used for the competitive support of collaborative research and/or innovation projects that will have an impact on enhancing the cooperation potential between Europe, Latin America and the Caribbean countries.

### Which countries are participating in the 5<sup>th</sup> EU-LAC Joint Call?

Argentina, Austria, Bolivia (tbc), Brazil, Dominican Republic, Germany, Panama (tbc), Peru, Portugal, Poland, Romania (tbc), Spain, Türkiye and Uruguay.

### Which institutions are providing funding for the call?

**Not all EU and LAC countries are listed above. Does that mean that the countries that are not listed are not eligible for participation and funding?**

Partners from countries that are not listed may also be part of consortia as long as they are able to clearly demonstrate an added value to the consortium and secure their own funding. However, the coordinator and the majority of partners in a consortium must be eligible by the funding organisations participating in this Joint Call. The self-financed/associated partners must provide the Call Secretariat with a **signed official letter** of support from their head of department or financial director. A pdf-version of this letter must be included as an annex at the end of the proposal when submitted.

**What are the fundamental principles of the 5<sup>th</sup> EU-LAC Joint Call?**

The fundamental principles of the call guiding the selection of projects to be funded are:

- **Transparency.** The process for reaching funding decisions will be clearly described and available to any interested party.
- **Equality of treatment.** All proposals shall be treated alike, irrespective of where they originate or the identity of the proposers.
- **Ethical considerations.** Any proposal that contravenes fundamental ethical principles may be excluded from being evaluated and selected at any time.

**Which research topics are eligible for funding under the 5<sup>th</sup> EU-LAC Joint Call?**

Research proposals can be submitted to the following six topics:

### **Do I need to have an agreement with my national funding body in order to submit a proposal within the EU-LAC Joint Call?**

No. Any eligible institution from a country participating in this call can submit a proposal directly to the Joint Call Secretariat using the PT-Outline webtool.

The participating countries have appointed national Call Contact Persons (CCPs) who will assist research institutions from the respective countries to submit applications. If you need special support to prepare your project, please contact your CCP (a list of CCPs is provided in Annex 1, page 20).

### **Which funding scheme will be applied in the Joint Call?**

The 5<sup>th</sup> EU-LAC Joint Call follows a **coordinated funding scheme**. This means that each Funding Party is funding its own national research team within a multilateral project (“**virtual common pot**”). The country contributions are listed in the above funding contribution table.

### **How do I submit a project proposal under the EU-LAC Joint Call?**

Project proposals are submitted through the web-based call management system PT-Outline. Please visit [https://ptoutline.eu/app/5eulac\\_call2025](https://ptoutline.eu/app/5eulac_call2025) and follow the indications provided.

Note that proposals submitted by post, e-mail, fax or any other means will not be accepted and rejected without further review.

### **In addition to the online submission procedure, should I submit a paper copy of the proposal?**

No, you should not send a paper version of the project proposal to the Call Secretariat. However, some funding organisations may ask for a paper copy of the proposal and further information (see national rules at [5th EU-LAC Joint Call in STI 2025 | EU-CELAC](#)).

### **Is there a deadline for the submission of a project proposal?**

Yes, the deadline for submission of research proposals is **22 May 2025, 5 pm CEST**. After this date the online submission system will be closed.

### **What are the national eligibility criteria?**

The present joint call includes different national funding organisations with their own call management system. The respective national funding rules and procedures and national eligibility criteria have been defined by the participating countries (see national rules at [5th EU-LAC Joint Call in STI 2025 | EU-CELAC](#)). Project partners are advised to check in advance what type of costs are eligible for national beneficiaries as well as the funding rates and limits of the countries concerned.

### **Which types of institutions are eligible for participation and funding?**

Applicants can represent public and private scientific-, research-, technological- and innovation institutions on national, federal or EU-LAC regional level, research active industry and NGOs and other institutions involved in research and or innovation activities, as long as they are eligible for funding according to the respective national and/or institutional rules. To check if your institution is eligible for funding, see the specific internal/national funding rules at [5th EU-LAC Joint Call in STI 2025 | EU-CELAC](#) and/or contact your national CCP, Annex 1, page 20).

### **How can I find appropriate research partners?**

The EU-LAC Interest Group, in collaboration with the ENRICH in LAC Centre, facilitates the identification of partner institutions across Latin America, the Caribbean, and Europe through a free partner search tool available at <https://europe-lac.b2match.io/page-2521>.



### **Can I be evaluator and partner of a project proposal at the same time?**

No! If you are a coordinator or partner in a project proposal of the 5<sup>th</sup> EU-LAC Joint Call, you are not allowed to perform as evaluator.

Evaluators are selected by the Group of Funding Parties from a database following a pre-selection procedure through the Call Secretariat.

### **What is the role of the coordinator?**

The project coordinator has the overall responsibility for the project and represents the consortium before the Call Secretariat. The coordinator is responsible for submitting the proposal and will receive the results of the evaluation. The contact data of the coordinator (and optionally of her/his representative) as well as of the institution must be included in the proposal.

It is recommended that the coordinators counter check the eligibility of all partners with the CCPs (see list of CCPs in Annex 1, page 20). Coordinators are allowed to contact the partners' national CCPs.

### **What is the role of the principal investigator?**

There should be a principal investigator (PI) for each of the national research groups. The PI from each country is the contact person for the respective national funding organisation.

One of the PIs should be appointed as coordinator by the project consortium to represent the consortium, submit the proposal and communicate with the Call Secretariat.

### **Must all partners be included in the project proposal at the submission stage?**

Yes. The whole consortium must be included in the proposal. It is important to ensure that the minimum participation requirements are met (see next question below) and that all consortium partners are eligible for funding according to the national eligibility and funding rules.

### **How many partners must cooperate in a project proposal?**

Each consortium submitting a proposal must include at least four eligible partners from four different countries, from a minimum of two countries in each region. Please refer to the table on page 4 to identify the participating funding agencies and the topics they support.

Some funding organisations may define a maximum number of national partners applying for funding in their institutional rules. However, the coordinator and the majority of partners in a consortium must be eligible for the funding organisations participating in this Call and comply with the minimum number of eligible partners as indicated above. Involvement of research infrastructures from both regions is recommended.

**Self-financed associated partners** may also be part of the consortia if they can clearly demonstrate an added value to the consortium and secure their own funding.

The associated partners must provide the Call Secretariat with a **signed official letter of support** from their Head of Department, Financial Director, or equivalent position, stating the commitment of the organization/company to provide its own funding. This letter must be annexed to the proposal submission form.

Only transnational projects will be funded. Each consortium should have the optimal critical mass to achieve ambitious scientific/innovation goals and clearly show an added value resulting from their cooperation.

### **Can I submit more than one proposal as a coordinator?**

No. However, one research institution – as a legal entity – is allowed to participate as a coordinator or partner in several project proposals.



### **May I submit a proposal twice?**

A given proposal may only be submitted for one of the topics supported within the framework of the 5<sup>th</sup> EU-LAC joint call; otherwise it will be considered non-eligible.

Researchers are only allowed to participate in one proposal as principal investigator of the coordinating institution. However, national funding rules may impose additional eligibility criteria regarding participation in multiple proposals, to be checked with the respective CCP.

### **What happens if one of the project partners is found non-eligible for funding after a project proposal is submitted?**

If the Project Coordinator does not meet the international or national eligibility requirements, the proposal will not be admitted to the evaluation procedure.

In case (a) Co-applicant(s) is (are) not eligible, the proposal may still be eligible if the eligibility criteria are met without this (these) partner(s).

### **Should I provide a detailed financial plan when submitting a project proposal?**

Yes. The project coordinator is expected to calculate the overall costs and the requested amounts per partner. In the project description template a detailed description of the requested funds for each cost category is asked for (e.g. personnel costs, travel- and other direct/indirect costs or costs related to the use of research infrastructures, such as equipment, software, consumables, secondments, data access etc.).

### **How many applicants from a country are allowed to participate in a project?**

Each funding organization decides about a maximum number of national partners applying for funding. Please ask your CCP (page 20, Annex 1) in case this is not defined in the national rules of your country.

### **What are the requirements for a Consortium Agreement?**

Each consortium selected for funding must provide a Consortium Agreement (CA) signed by all participants to clarify the potential Intellectual Property Rights (IPR) matters (such as licensing in, licensing out, patent and exploitation strategy). The research consortium must sign the CA within 3 months following the official project start date (except for projects involving polish partners, see footnote<sup>7</sup>) and send it to the Call Secretariat (uecelac@fecyt.es). It must address (as a minimum), the following points:

- Common start date and duration of the research and / or innovation project
- Organization and management of the project
- Role and responsibilities of each partner's resources and funding
- Confidentiality and publishing
- Intellectual Property Rights
- Decision making within the consortium
- Handling of internal disputes
- The liabilities of the research partners towards one another (including the handling of default of contract)

Any issues regarding funding are a bilateral matter between each project partner and the relevant funding organization and should be excluded from the CA. The CA, together with any other information required by national rules, must be made available upon request to the national funding agencies.

Standard documents that can be used as templates and modified according to the specific needs of the

### **What are the evaluation criteria for a project proposal?**

The evaluation procedure will be done according to the criteria defined in the following:

#### **1. Excellence**

- Clarity and pertinence of the objectives;
- Credibility of the proposed approach;
- Integration of diversity considerations in submitted proposals, as well as underrepresented populations in the planned research/innovation. This includes not only diversity in the consortium, but also the inclusion of diversity perspectives and analysis in the research/innovation itself if it is relevant. A project is considered diversity (or gender) relevant when it concerns individuals or specific groups of people and/or when its findings may affect individuals or specific groups.
- Soundness of the concept, including trans-disciplinary considerations, where relevant;
- Extent to which the proposed work is ambitious, has innovation potential, and is beyond the state of the art (e.g. ground-breaking objectives, novel concepts and approaches).

#### **2. Impact**

- Expected impacts listed in the description under the relevant topic;
- Enhancing research and innovation capacity and integration of new knowledge;
- Any other environmental and socially important impacts;
- Implementation of Open Science measures (early and open sharing of research; research output management; providing open access to research outputs i.e. publications, data, software, algorithms, etc.), participation in open peer review; involvement of relevant actors including citizens, civil society and end users in the co-creation of R&I contents and agendas;
- Effectiveness of the proposed measures to exploit and disseminate the project results (including management of IPR), to communicate the project and to manage research data where relevant;
- Added value for the EU-LAC cooperation in STI;
- Mobility, networking and training of human resources in both regions.

#### **3. Quality and efficiency of the implementation**

- Coherence and effectiveness of the work plan, including appropriateness of the allocation of tasks and resources;
- Complementarity of the participants within the consortium (if relevant) and gender balance among them;
- Appropriateness of the management structures and procedures, including risk and innovation management.

#### **4. Economic impact, applicability and exploitation of results**

- Potential for economic impact and exploitation/transfer of results;
- In case of industry and SME participation: Strengthening competitiveness and growth of companies by developing innovations that meet the needs of global markets and, where relevant, deliver such innovations to the market;
- Feasibility;
- Involvement of stakeholders;





- Communication and dissemination of results;
- Exploitation and transfer of results;
- Management of intellectual property issues and consortium agreements.

### What are the rating scores for a project proposal?

The evaluators are requested to assess proposals against a set of criteria, each of which may be awarded a maximum of 5 points per criterion, 20 points maximum, according to the following scale:

<b>EXCELLENT = 5 points</b> The proposal successfully addresses all relevant aspects of the criterion. Any shortcomings are minor.
<b>VERY GOOD = 4 points</b> The proposal addresses the criterion very well, but a small number of shortcomings are present.
<b>GOOD = 3 points</b> The proposal addresses the criterion well, but a number of shortcomings are present.
<b>FAIR = 2 points</b> The proposal broadly addresses the criterion, but there are significant weaknesses.
<b>POOR = 1 point</b> The criterion is inadequately addressed, or there are serious inherent weaknesses.
<b>0 points</b> The proposal fails to address the criterion or cannot be assessed due to missing or incomplete information.

No additional criteria will be used for evaluation and selection of the proposals.

### What is the evaluation procedure for the EU-LAC Joint Call?

The selection of the proposals for funding is based on an international, independent remote peer-review procedure. A dedicated pool of evaluators, consisting of external independent experts, will assess anonymously the submitted proposals. Each proposal will be evaluated by two external independent evaluators. Following the peer-review process, Scientific Expert Committees, consisting of scientifically multidisciplinary experts experienced in managing, following and evaluating transnational projects in each of the thematic areas, will consolidate the results of the evaluation and make recommendations to the Group of Funding Parties (GFP).

The final recommendation for funding rests with the Group of Funding Parties. The formal funding decision will be taken by the respective national funding party.



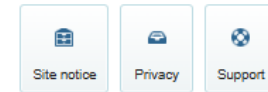

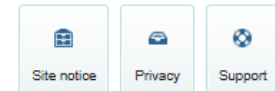
