Funding for Peruvian organizations is granted by CONCYTEC through PROCIENCIA (executive branch). Peru participates in this call funding projects in four topics:

1. Biodiversity, incl. agriculture and food security

- Challenges, opportunities and projections in food security 2

2. Bioeconomy and Nature-based Solutions

- Bioeconomy and Nature-based solutions to address climate change and biodiversity loss, promoting sustainability and climate resilience in urban and rural contexts.

3.2. Health

- Infectious diseases

4. Energy

- EU-LAC Cooperation for energy transition

Who can apply?

- ✓ Universities that are licensed by SUNEDU on the closing date of the application.
- ✓ Public Research Institutes (IPI)
- ✓ Non-profit public or private research and/or technological development and/or technological innovation centers or institutes. In the case of public entities, they must be constituted as executing units.
- ✓ Public or private Productive Innovation and Technology Transfer Centers (CITEs).
- ✓ Peruvian companies.

What types of costs are eligible for funding?

- Human resources
- Equipment and durable goods
- Materials and supplies
- Tickets and travel expenses



- Specialized consultancies
- Third party services
- Logistical operating expenses

Upper funding limits for eligible costs:

The upper Peruvian funding limit for each consortium is 100,000.00 Euro, distributed through a period no longer than 36 months.

02 projects will be financed in “Biodiversity, including agriculture and food security”; 02 projects in “Bioeconomy and nature-based solutions” and 01 project in “Health” and 01 project in “Energy” respectively.

Additional national eligibility criteria for the proposal beyond the general criteria in the Terms of Reference of the Joint Transnational Call:

1. The Principal Investigator and other researchers must be enrolled in the National Directory of Researchers and Innovators (<https://ctivitae.concytec.gob.pe/appDirectorioCTI/>).
2. All Peruvian teams must register their participation in this call at PROCENCIA <https://prociencia.gob.pe/> Call: Research Infrastructure: EU-LAC
3. Peruvian applicants must not be registered in the ‘Registro de No Elegibles’ – RENOES.
4. Organizations applying for Peruvian funding must be domiciled in Peru.
